ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY

In consideration of the undersigned having the opportunity to participate in baseball camps operated by Tyler Dawson Baseball LLC (TDB) in and upon certain facilities located at the United States Air Force Academy (Academy), the undersigned voluntarily and knowingly signs and delivers this Assumption of Risk, Waiver and Release of Liability.

TDB makes every reasonable effort to operate and maintain the sports camp facilities to protect against the exposure to COVID-19 virus or any other communicable disease in accordance with federal and state guidelines. As noted by government health officials, complete isolation from the virus is impossible. Accordingly, TDB, the AFAAC and the Academy cannot and do not promise to eliminate the risk of exposure to COVID-19 or any other communicable disease and cannot and do not promise that a participant will not contract COVID-19 or any other communicable disease. Participant acknowledges that AFAAC and the Academy have informed him/her that the sports camp facilities are not risk-free, that it is possible participant may contract COVID-19 or any other communicable disease during his/her presence at the sports camp facilities, and that participant freely chooses to enter and be present within and upon the sports camp facilities, and to participate in all sports camp activities, with awareness and assumption of the associated risks.

The undersigned understands and acknowledges the risks inherent in participating in sports activities and, specifically, sports camps operated by TDB. The undersigned also understands and acknowledges that an inherent risk of exposure to COVID-19 exists in any place where people are present and by coming onto the sports camp facilities and participating in activities in and about the sports camp facilities.

The undersigned does hereby voluntarily assume all risks incident thereto, including all risks related to infectious disease or viruses, including exposure to COVID-19, and I accept full responsibility for any injury, illness, disability, paralysis, death, loss, or damage which I may incur or suffer (whether to person or property) as a result my use and occupancy of, and presence in, any portion of the camp facilities.

The undersigned agrees to observe and abide by any applicable rules, procedures and guidelines established by Tyler Dawson Baseball LLC and the AFAAC, as well as applicable rules, procedures, regulations, ordinances, orders, requirements, requests, and guidelines established by governmental authorities, including, without limitation, those pertaining to public health and safety (in particular, as pertains to COVID-19). If I observe any unusual or significant condition or hazard during my presence at the sports camp facilities, I will remove myself from participation and bring such matter to the attention of the nearest employee or representative of Tyler Dawson Baseball LLC or the Academy.

The undersigned hereby waives, releases and discharges Tyler Dawson Baseball LLC , its directors, officers, employees, and agents, and the AFAAC, its officials, officers, employees, and agents, from and against any and all injury (including paralysis, disability, death or other harm), illness, loss, liability, damage (including to person or property), claims, demands, legal actions, causes of action, costs and expenses, and other liability of any kind and nature whatsoever, which may arise out of, result from, or be connected in any manner with my participation in the sport's camp and my use and occupancy of, and presence in, the sports camp facilities, even if arising out of the negligence of TDB, the AFAAC, the Academy, or anyone hereby released.

Neither Tyler Dawson Baseball LLC nor the AFAAC provide insurance for personal injury, loss, damage to or theft of personal equipment. The undersigned accepts full responsibility for any damage to their personal property and equipment as a result of, caused by or connected with the undersigned's participation in the sports camps and their use and occupancy of any portion of the sports camp facilities.

I HAVE READ THIS ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY, UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT (clicking agree), AND SIGN IT FREELY AND VOLUNTARILY.
