WAIVER, RELEASE OF LIABILITY & ASSUMPTION OF RISK

PLEASE READ THIS DOCUMENT CAREFULLY. IT AFFECTS YOUR LEGAL RIGHTS.

In consideration of my child's/my participation in the Bradley University Braves Youth Skills Camp ("Camp"), operated by Bradley University ("Bradley") and Play'n Sports, LLC, I, the undersigned parent or legal guardian (or participant if 18 or older), agree to the

following:

1. Assumption of Risk. I acknowledge that participation in baseball camp activities involves inherent risks, including but not limited to: physical contact with balls, bats, and equipment; overexertion; slipping, falling, and collision with other participants or structures; and other risks associated with athletic activity. I voluntarily accept and assume all such risks on behalf of myself and/or my minor child.

2. Release of Liability. To the fullest extent permitted by law, I hereby release, waive, discharge, and covenant not to sue Bradley University, its Board of Trustees, officers, directors, coaches, employees, volunteers, agents, Play'n Sports, LLC, and any affiliated entities (collectively "Released Parties") from any and all liability, claims, demands, or causes of action arising out of or related to any loss, damage, injury, or death that may be sustained by the participant, whether caused by the negligence of the Released Parties or otherwise.

3. Indemnification. I agree to indemnify and hold harmless the Released Parties from any loss, liability, damage, or cost they may incur due to my child's participation in Camp, whether caused by negligence of the Released Parties or otherwise.

4. Medical Authorization. In the event of illness or injury, I hereby authorize the Released Parties to obtain emergency medical treatment for the participant. I understand that every effort will be made to contact the parent/guardian first. I agree to be responsible for all medical costs incurred.

5. Photo/Video Release. I grant Bradley University and Play'n Sports, LLC the right to photograph and/or video record the participant during Camp activities and to use such images for promotional, educational, or marketing purposes without compensation.

6. Code of Conduct. I understand that participants are expected to demonstrate sportsmanship, respect for coaches, staff, and fellow campers. Bradley University and Play'n Sports reserve the right to dismiss any participant for misconduct without refund.

7. Governing Law. This agreement shall be governed by the laws of the State of Illinois. If any provision is found unenforceable, the remaining provisions shall remain in full force and effect.
